#### Summary

Japan is known for its long-standing and extensive history of government interest in picking up technological paths and working hand-in-hand with the industry toward technological innovation. Although this practice allegedly contributed to significant success for several high-tech industries in the past, it is now widely considered as less relevant to the current economic context. The "catch-up" strategy had to be replaced by a search for emerging technologies, where an interdisciplinary approach is crucial and mode-2 style thinking is a driving force.

Also science-based industries are gaining their importance, and the academic community's involvement is becoming crucial in innovation process. In this context, ever more systemic and cross-boundary approaches are needed. Because of the recent and drastic environmental changes, the Japanese government is facing new challenges to coordinate and promote innovations.

In this seminar, we will present this changing institutional framework and proceed to a critical analysis of Japanese innovation policy based on the recent literature on innovation.

# **Short Biography of Yuko HARAYAMA**



Dr. Yuko Harayama received her Ph.D in Education Science in 1996 and a Ph.D in Economics in 1997, both from the University of Geneva.

Dr. Harayama is a Professor in the Department of Management Science and Technology at the Graduate School of Engineering of Tohoku University. Prior to joining Tohoku University, she was an Assistant Professor in the Department of Political Economy at the University of Geneva and a Fellow at the Research Institute of Economy, Trade and Industry in Japan. She also served as an executive member at the Council for Science and Technology Policy in Japan.
