Summary

Despite large scale redundancies after the financial crises in 1997-1998, the mutual commitment or social contract between employees and their employer concerning dismissal avoidance did not disappear. Two kinds of sub-systems that are useful for reducing the possibility of dismissals: "Employment Adjustment Systems" and "Employment Portfolio Systems" were reworked to cope with the critical economic conditions. The term "Employment Portfolio Systems" refers to strategic usage of various types of "non-regular" workers. In the seminar, I will discuss the implications of the changes in the Systems for the current debate on temporary workers and the "Gap Society".

Michio NITTA is professor of international relations at the University of Tokyo, Institute of Social Science. He is, since its creation, director of the International Associated Laboratory: Comparative Approaches in Social Sciences and Humanities (LIA-CASSH, CNRS/University of Tokyo). He is a member of the Central Labor Relations Commission, as well as the Chairperson of the Japan Industrial Relations Research Association. He published numerous books and articles in English among which: "Knowledge-Driven Work", in Joel Cutcher-Gershenfeld *et al.*, Oxford University Press, 1998; and in Japanese: *Employment Systems in a Changing Japanese Society*, University of Tokyo Press, 2003; *Japanese Style Employment System* (with Hisamoto Norio), Nakanishiya shuppan, 2008; "Evolution of Japanese Employment Systems in the Lost Decade and After", *Journal of Social Science*, vol. 60, n° 1, January 2009.
